Ms. Trask's practice focuses on civil litigation and emphasizes complex commercial litigation including intellectual property (patent and trademark infringement; trade secret misappropriation), antitrust, securities, breach of contract, and fraud. She has supported both plaintiffs and defendants in cases involving oil and gas, products liability, and insurance. Ms. Trask boasts extensive experience assisting institutions and individuals in matters involving regulatory enforcement and white-collar defense.

Over her 30-year career, Ms. Trask has taken part in hundreds of jury trials across 25 states and U.S. territories. Some of her more notable engagements include assisting:

- Plaintiff in *Dominion Voting Systems, et al. v. Fox News Network, LLC, et al.* The case was set to be tried in the spring of 2023, but Fox News paid \$787 million to resolve the case prior to trial.
- Plaintiff in *PanOptis v. Apple* before Judge Gilstrap in EDTX. The case was originally tried in August of 2020: the first in-person patent trial of the pandemic. The jury awarded PanOptis \$506 million. Judge Gilstrap ordered a new trial on damages, and in July of 2021, a second jury awarded PanOptis \$300 million.
- Plaintiff USAA in several matters against competing banks before Judge Gilstrap in EDTX. In the first two trials conducted against Wells Fargo, the jury awarded \$200 million and \$102.8 million.
- Defendants in *Title Source, Inc. v. HouseCanary, Inc. fka Canary Analytics, Inc.* in San Antonio, Texas. The 12-person jury found unanimously for our client on all issues, HouseCanary, awarding \$706.2 million.
- Plaintiff in *Waymo, LLC v. Uber Technologies, Inc.* before Judge Alsup in San Francisco. The dispute over the alleged theft and use by Uber of Waymo's trade secrets transfixed the tech world for months. The case settled five days into trial.
- Plaintiffs in *Jibe Audio, LLC et al. v. Jimmy Iovine et al.* in Los Angeles Superior Court. The jury awarded Steven Lamar \$25.25 million in his dispute with Dr. Dre and Jimmy Iovine over royalties owed for his role in creating the now iconic Beats headphones.
- Plaintiffs in *KAIST IP US, LLC v. Samsung Electronics Co., LTD, et al.* in Federal Court in Marshall, Texas. The jury found that defendants Samsung, Qualcomm and Global Foundries infringed a patent owned by KAIST IP US and awarded \$400 million in damages against Samsung.
- Plaintiffs in *Green Mountain Glass, LLC and Culchrome, LLC v. Saint-Gobain Containers, Inc., d.b.a Verallia North America* in the District of Delaware. The jury found willful infringement of a U.S. Patent and awarded damages of \$50.3 million.
- Defendants SAC Capital and Stephen A. Cohen in *Kaplan v. SAC Capital Advisors* in the Southern District of New York. The suit, resulting from the largest insider trading investigation in U.S. history, was resolved prior to trial.
- Plaintiffs in *Cioffi, et al. v. Google, Inc.* in the Eastern District of Texas. The jury found that Google's Chrome Browser Sandbox technology infringed three U.S. Patents owned by inventors Al Cioffi and Al Rozman (deceased). The jury awarded damages of \$20 million.

- Defendant Texas Brine in *Gustave J. Labarre, Jr., et al. v. Occidental Chemical Company, LLC., et al.*, a class action brought by landowners in the wake of the Bayou Come sinkhole incident in Assumption Parish, LA. The case was resolved prior to trial.
- Plaintiffs in *Meyer/Brunson, et al. v. Health Plan of Nevada, Inc.* The negligence case was brought against the insurer in the wake of a hepatitis C outbreak in Las Vegas that was traced to colonoscopy clinics owned by Dr. Dipak Desai (now serving a prison term). The resulting \$525 million verdict remains the largest verdict in Nevada history.
- Defendant Transocean in the *Multidistrict Litigation, Oil Spill by the Oil Rig "Deepwater Horizon"* in the Eastern District of Louisiana. The negligence case against Transocean arising from the Macondo Well incident on April 20, 2010 was resolved prior to trial.
- Plaintiff in *Centocor v. Abbott* in the Eastern District of Texas. The \$1.67 billion result remains the largest patent infringement verdict returned by a jury in U.S. history.
- Defendant Oprah Winfrey in *Texas Beef Group v. Winfrey* in the Northern District of Texas. The jury returned a defense verdict in the libel case.
- Plaintiff in the *ExxonMobil, Corp. v. Lloyd's, London* excess coverage case involving the Valdez oil spill. The resulting \$250 million verdict was one of the largest in Texas that year.
- Defendants, Reliant Energy and four Reliant Energy traders in *The United States v. Reliant Energy Services, Inc., et al.*, indictments arising out of the California Energy Crisis of 2000. The case was resolved prior to trial.

Ms. Trask is a nationally recognized author and lecturer on juror psychology and various trial sciences. She is a member of the American Bar Association, The Bar Association of San Francisco, and the APA Psychology-Law Society. She serves as a Trial Consultant Advisor and liaison to the Civil Jury Project at NYU Law School.

She has been a member of the American Society of Trial Consultants since 1994 and served on its board of directors from 2005-2012 as Treasurer, President-Elect and President. Ms. Trask currently serves as the Chair of the ASTC/CJP joint working group.
